Disha Shikshan- V- Vikas Kendra's, E.B., Gadkari Homoeopathic Medical College, 1830/A/B, Kadgaon Road, Opposite Govt. Rest House, Gandhinglaj, Dist. Kolhapur- 416502 has applied for 1st- BHMS course with 50 seats for the academic year 2025-26. The College has submitted the Part I information in which the entire functional profile has been narrated. MARBH has examine the profile of the College as to whether the college fulfils the Minimum Essential Standards to be fulfilled as per the prevailing regulations under clause 28 of NCH Act 2020.

MARBH conducted inspection on 16.06.2025 & 17.06.2025, followed by hearing on 01.07.2025 and issued Permission (F. No. 4-7/2025-26/NCH(MARBH)/(115-18)/4058 dated 01.07.2025) to college in BHMS course with 25 seats (reduced from 50 seats) for the academic year 2025-26 observed the following shortfalls:-

1. Deficiency of Teaching Faculty: (09 Deficiencies)

- One Professor & two Assistant Professor are not available in Department of Human Anatomy.
- One Assistant Professor is not available in Department of Physiology.
- One Professor is not available in Department of Homoeopathic Materia Medica.
- One Professor is not available in Department of Surgery.
- One Professor is not available in Department of Community Medicine.
- One Assistant Professor is not available in Department of Organon of Medicine.
- One Assistant Professor is not available in Department of Practice of Medicine.

viii. Principal post is vacant.

2. Miscellaneous:

- i. Pay scale of all the teaching staff is not according to MES- 2024.

As evident from the above statement, a total number of 09 UG teachers are deficient against the requirement of 40 + 1 for 100 seats UG college (As specified in MES, 2024). Pursuant to F.No. :3-2/MARBH/NCH/2025-26/162-169 dtd. 16/04/2025 issued by MARBH, a college can avail 15% relaxation against the required number of teachers for Academic Year 2025-26 only. After allowing relaxation of 15%, college still have deficiency of 03 teacher. However, such relaxed number of teachers may be appointed at the earliest for smooth conduct of course.

Thereafter, college applied for grievance (vide letter no. DSVK/EBGHMC/NCH/02/2025/5926 dated 29.07.2025) to Chairperson of National Commission for Homoeopathy. The Committee recommends grant of permission for intake of 50 seats (Letter no- 30-5/2025-26/NCH-GR(88)/5547 dated: 20.08.2025) in the 1st BHMS course for the academic session 2025-26.

Thereafter, in compliance with the decision of National Commission for Homoeopath, **MARBH has decided to grant Conditional Permission to college for continuing admissions in BHMS course with 50 seats for the academic year 2025-26** following conditions:

- i. Pay scale of all the teaching staff should be according to MES- 2024 within one month of issue of letter.
- ii. College should appoint 03 teaching staff within one month of issue of letter.

All admissions shall be made from NEET qualified candidates only. It is further informed that minimum 15% of seats of the permitted intake capacity of 50 seats of BHMS shall be treated as All India Quota. Counselling for seats under All India Quota shall be conducted by the Central Government and counselling for the remaining 85 % seats or as the case may be, shall be conducted by the concerned counseling authority of the state/UT designated by Central Government. The permission of the college stands withdrawn if the college fails to comply with the aforesaid direction of the Central Govt. for All India Quota or the student admitted thereunder.

The Category wise list of the selected candidates may be informed to the Medical Assessment and Rating Board for Homoeopathy after the process of admission is completed. Any admissions carried out other than NEET qualified students will not be approved by the Medical Assessment and Rating Board.

Permission to college can be withdrawn or denial in the subsequent year if college is found deficient in compliance to MES- 2024 anytime during the academic year.

(vii) *Settlement of advance(s) / dues of any section of the University including affiliation fees if pending with the College and any other deficiency observed by any regulating authority, please submit within 03 (three) months, otherwise, no action will be taken on teacher's proposal for approval / PG Recognition received from your College.*

Important Note:

- 1) This Conditional Continuation / Extension of affiliation is issued for the A.Y. 2025-2026 subject to the permission of National Commission for Homoeopathy / Government of India/Department of AYUSH, New Delhi. Further, if the permission is declined by the said authorities, this Conditional Continuation / Extension of Affiliation shall be treated as cancelled. The College is not authorized to admit students for 1st Year of the course until receipt of permission of the National Commission for Homoeopathy / Government of India /Department of AYUSH, New Delhi.

- 2) The admission shall be done through the Competent Authorities only.
